FOUR CHURCH FARM REPORT

I'd like to begin by saying the Four Church Farm meeting is the 3rd Tuesday of the Month except December and February when we don't hold a meeting. Anyone from the four churches are welcome to come to our meetings. During the cold months we meet at Christ Lutheran Church. The rest of the year we meet at the

Four Church Farm at 6:00 p.m. We are always looking for help with the upkeep of the farm, so anyone who would like to help at the farm, just let us know. St. John's are scheduled to mow the 1st Wednesday of the month, St. Paul's the 2nd Wednesday, Christ Lutheran the 3rd Wednesday and on the 4th Wednesday, we take turns and when there's a 5th Wednesday, we use it for a Work day in addition to mowing, if there's something different that needs taken care of.

The officers were voted to remain the same for the year as the previous year. President: Dan Fischer, Vice President: Jim Rengert, Treasurer: Chaplain Bill Rauch, Secretary: Mark Finck. Our checkbook balance for the Farm as of January 1, 2023 is \$11,845.56. We also purchased a zero-turn mower for the Farm this year from Buckeye Valley Equipment for \$8079.00 it is a 23.5 hp and 60" cut, which was a good deal, since it was on sale from \$10,099.00. We still have one of the older riders which we use to help out, as some of us are still getting used to the zero-turn, which is a lot different than a regular rider. We had some water pipe that needed repaired and Chuck Hiles and some of his friends, Darrell Burden, Darrell Manifold, and George Powers met out there to replace the broken lines. Many thanks to the guys for their help, it's great when God provides at times when we get caught up with how we are going to go about fixing our problems and boom he blesses us again. Dan and Chuck tore out and replaced the deck by the women's restroom, it was in bad shape and we couldn't get the door opened. We also cleaned up the trail from some fallen trees. One of our picnic tables was falling apart so we got rid of it and repaired another and also brought one of the wooden ones out from the shelter to replace the one that was destroyed.

We did have our Four Church Farm Picnic in September, we didn't have a huge turnout but the ones that were there enjoyed a nice day of fellowship and eating which we Lutherans do enjoy. Many thanks to everyone who helped with the setup and food preparation. Weather providing our next meeting will be January 16, 2024, at Christ Lutheran Church, Heath, Ohio

PROPERTY COMMITTEE:

After a great deal of research and planning, the church parking lot was repaved in August. Licking County Schools agreed to pay a portion of the cost, since Phoenix School uses the lot on school days. Moving forward we are charging a yearly rental to be better prepared for future maintenance. In preparation for the paving, the basketball posts and chain link fence surrounding a portion of the lot were removed by Gene Lamp with some help from committee members.

Greta reports that the 5 Ring security cameras placed around the buildings are working well.

The steps outside the door leading to the sacristy had deteriorated. John removed the old and made a form for new steps of concrete (surplus concrete provided by the street construction crew). He also installed a gutter on the awning to avoid erosion of the new steps and refurbished the railing.

Tim added a couple coats of finish to the exterior sanctuary doors to prevent weathering and Charlie and Diane did maintenance on all of the HVAC units in the church building. Charlie and John repaired several toilets and Charlie replaced washers in the dripping utility sink. (We are preparing a list of routine work that needs to be done occasionally to guide future volunteers.)

We have contracted with a stone mason to replace the eroded stones at the main church entrance, to repair cracks and mortar on the exterior stone walls of the buildings, and to secure some of the stone caps on end gables. This work should be completed in the coming year.

With the construction of the roundabout we were concerned that our sign structure would have to be removed and rebuilt. This was not the case and there will be further repairs to the interior and exterior of the sign in warmer weather.

In December it was noticed that water was leaking through the sacristy's copper roof. When the repairs around the tower were done in 2022 we were told

that the copper roof would not last much longer. Durable Slate is making repairs, but we will need to plan for replacing this roof in the next few years.

We are very thankful for the ongoing volunteer work done by Gene Lamp and Tammy & Hank Trites to maintain our lawn and plantings, making St. Paul's attractive and inviting. Our sextons, the Fallers, have continued to be conscientious in their work and in reporting problems as they arise.

Because costs have increased greatly in recent years, we asked Council to increase the amount we could pay without congregational approval from \$2,500 to \$5,000. This was approved in the recent congregational vote.

RENTAL PROPERTY COMMITTEE:

All six rental properties are currently rented except for one pre-eviction rental.

During the past year, our current insurance company no longer insured rental properties which we now have American Modern for our rental properties. Due to increased taxes and insurance over the last four years, we were forced to increase the current rent per unit \$50.00 per month totaling \$3600.00 per year.

Our average rent per unit on six units is \$814.33 per month which includes one Metro Housing payment. As we make needed repairs, this amount will need to be increased.

We were able to negotiate a new monthly payment with our trash pickup saving us approximately \$675.00 per year.

During the year, we replaced one furnace and made necessary floor repairs and painting to another property.
